GSA OASIS shaken up

In another major shakeup at the General Services Administration, the senior management team of GSA's huge "OASIS" professional services multiple-award contract was abruptly reassigned to another office last month.

The OASIS senior leaders had created and managed OASIS and OASIS Small Business for several years. Many credit the team with the success of those programs.

Former OASIS program manager Todd Richards said he and senior team members Tommy Thomas,

Are the HUBZone changes enough?

Former SBA Assoc. Admin. says more improvements are needed

The Small Business Administration's "HUBZone" program for small business federal contractors has been struggling for years, and bills pending in the House and Senate propose various changes to boost the program.

But will those proposals--if approved and implemented--make the Historically Underutilized Business Zones program a success? That is an open question.

Weighing in on House bill HR 3294, John Shoraka, former SBA Associate Administrator for Government Contracting and Business Development, suggests that the proposed modifications might be too weak to make much of a differ-

"While this is a step in the right direction, the proposed changes do not go far enough to provide a meaningful impact to the deficiencies in the program," Shoraka wrote in a recent blog entry.

The HUBZone program

The HUBZone program has been struggling for years. The government's goal is to award 3% of contracts to HUBZone small businesses, but results have fallen short. In fiscal 2016, only 1.7% of contracts were awarded to HUBZone firms.

SBA OIG questions 8(a)s' eligibility IG says 10 firms accepted into 8(a) without full documentation

The criteria for participating in the Small Business Administration's business development program for small disadvantaged firms already are considered strict--but may become even more stringent as a result of a recent audit report.

The SBA Office of Inspector General (OIG) recently questioned the eligibility of 30 small businesses that had been certified as participants in the SBA 8(a) Business Development Program.

SBA officials allegedly approved the 30 firms as 8(a) participants without fully documenting into SBA information systems how all concerns raised about their applications had been settled. However, the OIG subsequently determined that SBA resolved eligibility concerns for 20 of the 30 firms.

10 firms' eligibility challenged

But the remaining 10 firms still raised eligibility concerns, the OIG said.

Specifically the OIG reported:

• Seven of the 10 firms under question did not have the "potential for success" that is required un-

"Historical weaknesses"

According to Shoraka, the HUBZone program has "historical weaknesses" that are obstacles to success.

HUBZone areas are tweaked and updated at least once a year, or whenever new census data becomes available, Shoraka wrote. "This constant and ever-changing landscape makes it difficult for a company to rely on and invest in its HUBZone status and its underlying infrastructure."

"As a result, fewer and fewer companies are willing to establish or relocate their companies in a HUBZone and invest in HUBZone employees and local communities. This results in the government having fewer and fewer qualified HUBZone companies to procure from in order to meet its 3% goal," Shoraka added.

The need for HUBZone firms to certify their status when getting started, and to recertify when awarded a contract, makes compliance even more difficult.

House bill

HR 3294 was introduced by Rep. Nydia Velazquez, D-NY, ranking member of the House Small Business Committee. Chairman Steve Chabot, R-OH, co-sponsored. The bill would establish a fiveyear cycle for determining the geographic boundaries of HUBZones. It also would change the calculations by which certain geographic areas qualify for the program, potentially adding as many as 1,000 rural and non-urban counties, according to the committee.

There also is language for better data collection on performance, and for faster response from the SBA to applicants.

Shoraka wrote that the changes were beneficial but would have limited impact. "These provisions may stabilize the program, but they will also limit the number of HUBZone areas, which would in effect limit the number of HUBZone firms in SBA's portfolio," Shoraka wrote. The bill also does not address contracting officers' concerns about staying ahead of the HUBZone area changes and with enforcing the requirement that 35% of HUBZone workers live in the zone, he added.

Senate changes

The Senate reduced the requirement for HUBZone employees to live in the zones to 33%, from 35%, in its version of the National Defense Authorization Act. See the 7/21/2017 edition for more. **More information:**

NDAA: loser pays for protests

The Senate version of the National Defense Authorization Act (NDAA) for fiscal 2018 could make losing a protest a lot more expensive.

The provision applies only to companies with revenues of over \$100 million in the previous year. Mostly large firms would be affected, but some small business contractors involved in distribution and manufacturing would be impacted as well.

Under the NDAA proposal, if the Government Accountability Office denies a protest against the DOD, the protester would have to reimburse DOD's costs for defending the protest.

"It is unclear how the government would track or calculate its costs, but they could be significant," Jon Williams, partner at PilieroMazza PLLC, wrote in a recent blog entry (http://goo.gl/ iPmFvc).

Reimbursement might be avoidable if the protest is withdrawn, or partial upheld by GAO.

The Senate bill also includes a provision to reduce the incentive for incumbent contractors to file protests to gain additional time (and money) performing the incumbent contract, Williams wrote.

der 8(a) rules. One firm had errors in its financial statements, and another had not operated in its primary industry for at least two years.

• Two of the 10 firms were lacking proof of their "good character" as required. One firm had multiple tax liens, but it was unclear whether those liens had been discharged in bankruptcy.

• Two of the 10 firms did not have proof that their owners were economically disadvantaged. In one of those cases, there were issues about a \$71,000 loan from the applicant's father that had not been resolved. • Two of the 10 firms did not show that the firm was controlled by a disadvantaged individual. In one case, the applicant was judged to be financially reliant on another firm.

• Two of the 10 firms did not have sufficient proof of their size as small businesses. In one of those cases, there appeared to be affiliation with a larger business, the report said.

Several of the 10 firms had multiple issues.

The inspector general made three recommendations, based on the findings. SBA said it would continue reviewing the eligibility of the 10 8(a) firms, and also agreed to strengthen its oversight and to improve its documentation.

8(a) eligibility may change

Some observers predict potential ongoing impacts to small businesses.

"The OIG's report is worth reading, as it may lead to changes in the 8(a) Program's eligibility criteria," Steven Koprince, government contracting attorney, wrote in a recent blog entry.

Additional industry sources also have told *Set-Aside Alert* that SBA contracting officials at public events recently have been talking about heightened oversight to rule out 8(a) fraud.

The SBA OIG report noted that there were no indicators of fraud in the 30 firms reviewed.

SBIC bills OKd

The House approved three bills aimed at increasing small business access to capital: HR 2333 increases the amount of capital for Small Business Investment Companies (SBICs) and HR 2364 increases what financial institutions may invest in SBICs. Also, HR 2056 raises the microloan lending limit to \$6 million, from \$5 million, and makes other changes in microloans.

Valerie Bindel and Cat Renfro were being moved to the "FEDSIM" of-fice.

GSA announced that Alexandra Rouse is the new principal contact for programmatic activities; Sheila Morrison is the principal contact for contracting activities; Robin Tice is the contracting officer for OASIS; Shaun Hankton is the contracting officer for OASIS Small Business; and Carley Graham is an OASIS contract specialist.

Industry was taken by surprise by the sudden personnel shift, with some calling the move "shocking" and "strange." Sources said OASIS Small Business was getting too big and Richards was getting too powerful. Other sources said there were personality differences at play.

OASIS Small Business had nearly \$1 billion in task orders in fiscal 2016, and OASIS, over \$1 billion, GSA reported on its OASIS dashboard. Another \$1.8 billion has been obligated this year.

Column: Empowering the OSDBU to be your advocate without its knowledge!

This is the second column in a series on strategies for engaging and leveraging the Office of Small & Disadvantaged Business Utilization (OSDBU).

Why you?

OSDBUs invest significant sweat equity in forging and maintaining relationships with contract officers and program officials. They engage their colleagues in "give and take" conversations to determine small business opportunities – the intersection of agency missions and small businesses' capabilities.

The OSDBU's mission is to advocate for and maximize small business contract opportunities (as mandated by Congress).

Your objective is for the contract officers and program officials to know, trust and like you. These relationships are the cornerstone of successful federal government contractors. The OSDBU can facilitate introductions for you for market research purposes and validation that the "Rule of Two" criterion is fulfilled. However, are you and your firm worth the OSDBU's investment of its reputation and political capital, for your benefit?

Are you making it easy for the OSDBU to assist your firm?

Your objective when engaging the OSDBU should be to equip and empower the OSDBU to advocate on your behalf. The OSDBU is responsible for performing a myriad of activities as outlined in Federal Acquisition Regulation (FAR) Subpart 19.201 so it is not resourced to provide ongoing time-intensive assistance. Therefore, your firm must be what I call an "add-water business" in order to maximize your relationship with the OSDBU.

"Add-water businesses" are procurement-ready firms to which the OSDBU can provide direction and information (the water) that the firms execute from that point forward.

What is a procurement-ready business?

• Possesses intimate knowledge of agency missions and current challenges.

• Understands the priorities of the agency Secretary, Deputy and Undersecretaries, and is *cognizant that a discrete set of objectives must be accomplished by political appointees in a short window.*

• Maintains knowledge of and leverages the Federal Acquisition Regulation (FAR) and agency acquisition regulations.

• Proactively presents to the OSDBU procurement ideas that assist the agency in achieving its mission, for example by *transforming from capability briefings into articulating how their innovations and product/service will enable the agency to overcome its challenges.*

• Targets specific contract awards and/or missions within an agency. If you ask an OSDBU about a specific contract at an agency, the OSDBU can react more effectively than if you ask about a broad category of contracts.

• Concludes the meeting with the OSDBU with three actionable, reasonable and achievable actions for the OSDBU, keeping in mind that the OSDBU (like all people) is most responsive when it can answer the question, what's in it for me?

Information is Power

The OSDBU's assumption is that you possess at least a working knowledge of federal government contracting and understand "how the system works." So, how do you gain access to information to become an "add-water business"?

Good sources of free information are the U.S. Small Business Administration (SBA) and the Procurement Technical Assistance Centers (PTAC). sights by doing the following:

• Conduct an on-line search of political and career decision-makers for your targeted agency and specific programs within the agency. Senior level officials give speeches, interviews and testimonies on a regular basis and they can be very revealing.

• Watch agency budget hearings before their respective appropriations committee(s). Agency's priorities are supported by their budget requests. Identify budget priorities where the administration and the appropriators agree and disagree. Also attempt to tie agency budget priorities to contract actions.

• Identify and contact the SBA Procurement Center Representative for your targeted agencies. They can provide useful insight into agencies' acquisition processes and contracts.

• Read the Office of Inspector General's (OIG) report on your targeted agency's top management challenges. This report will influence agency management priorities.

• Seek the assistance of a professional with specialized knowledge of the nuances of federal government contracting processes and procedures.
